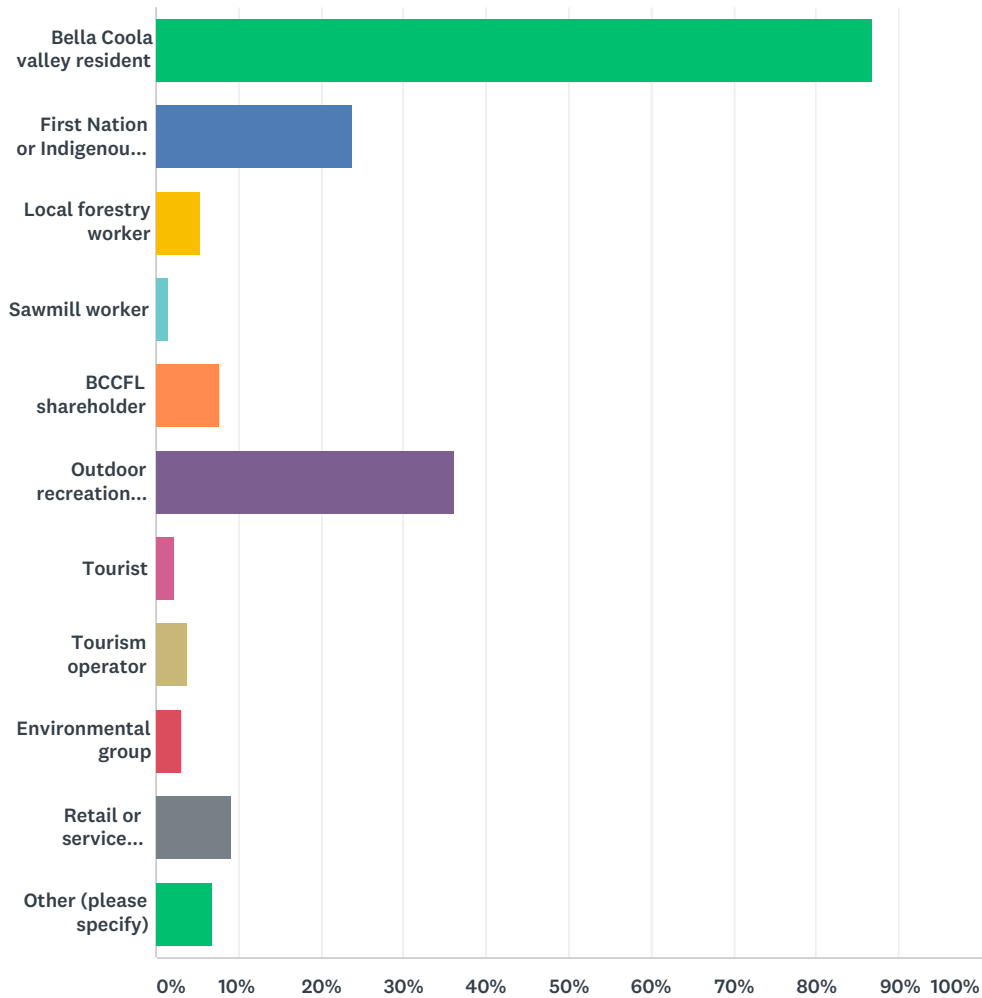


Q1 Which of the following best describes you? Check all that apply.

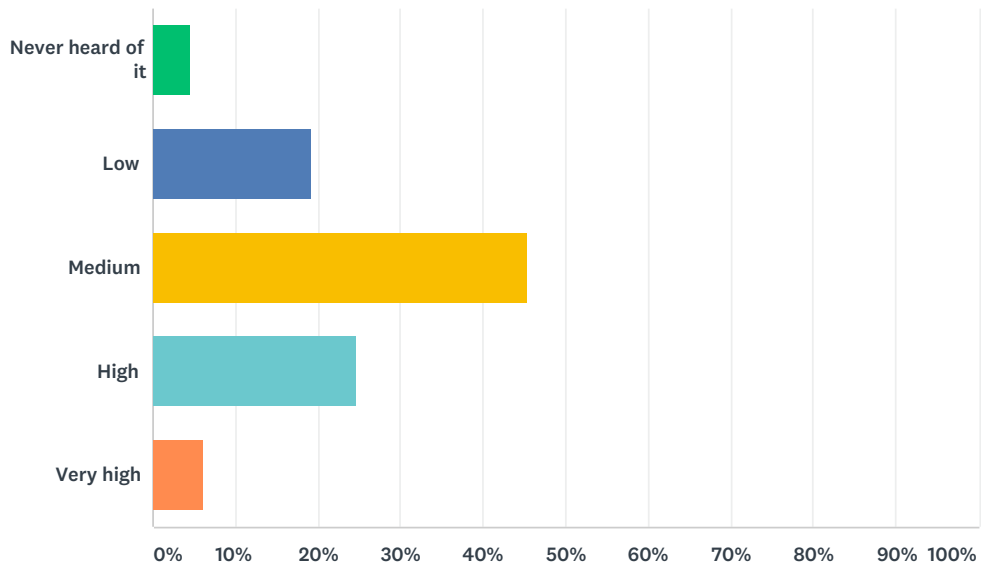

Q2 How would you rate your level of awareness of the Bella Coola Community Forest?

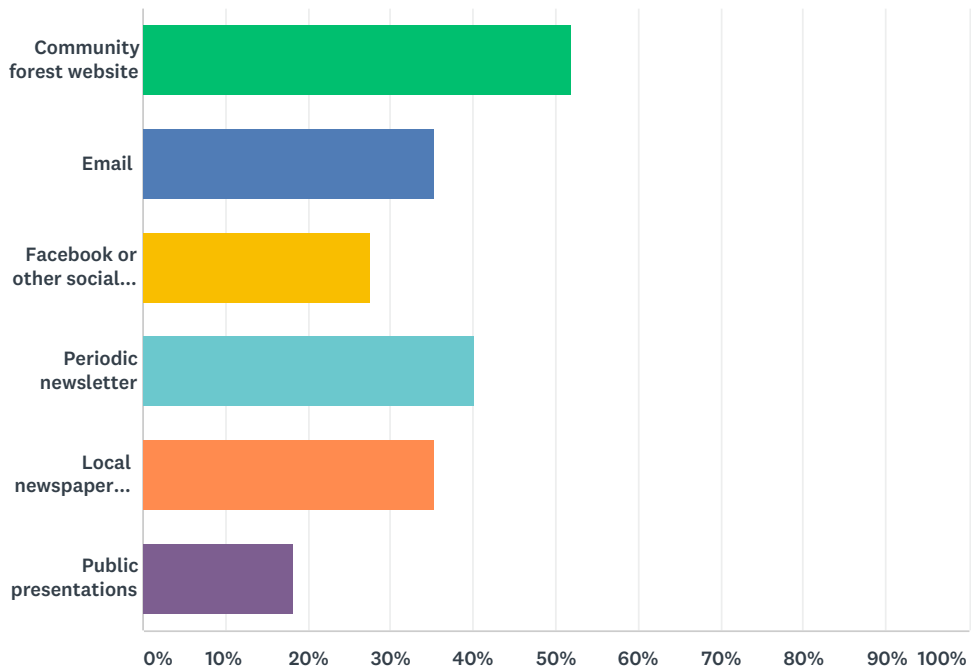

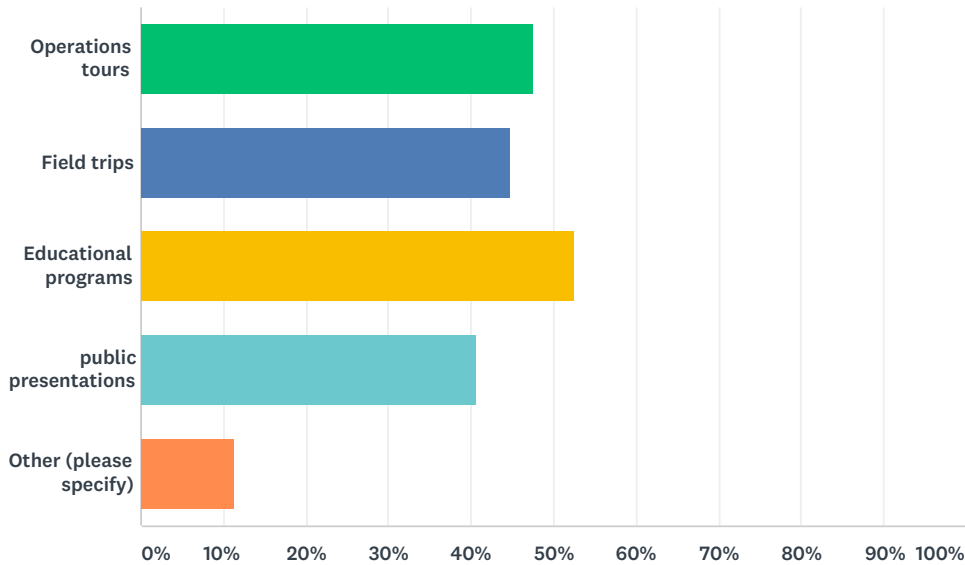

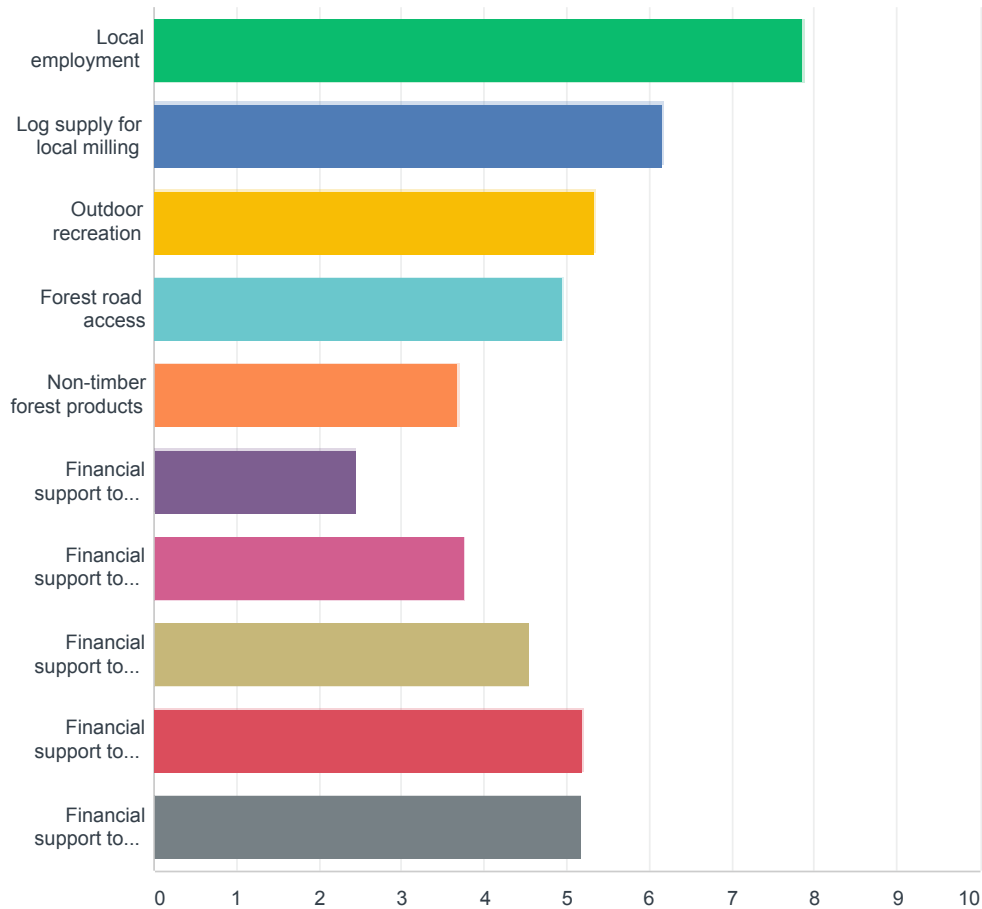

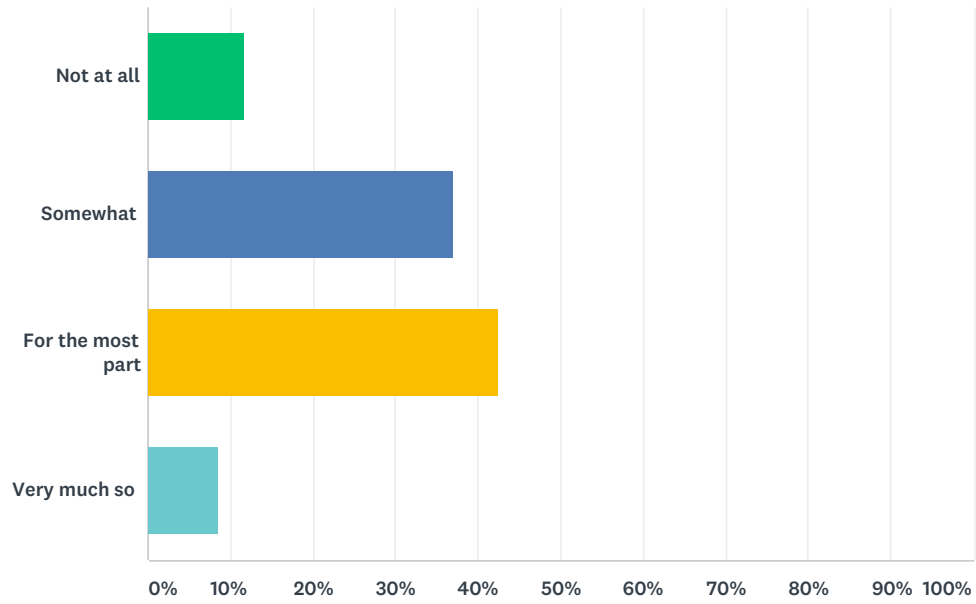

Q6 Is the community forest meeting your expectations?

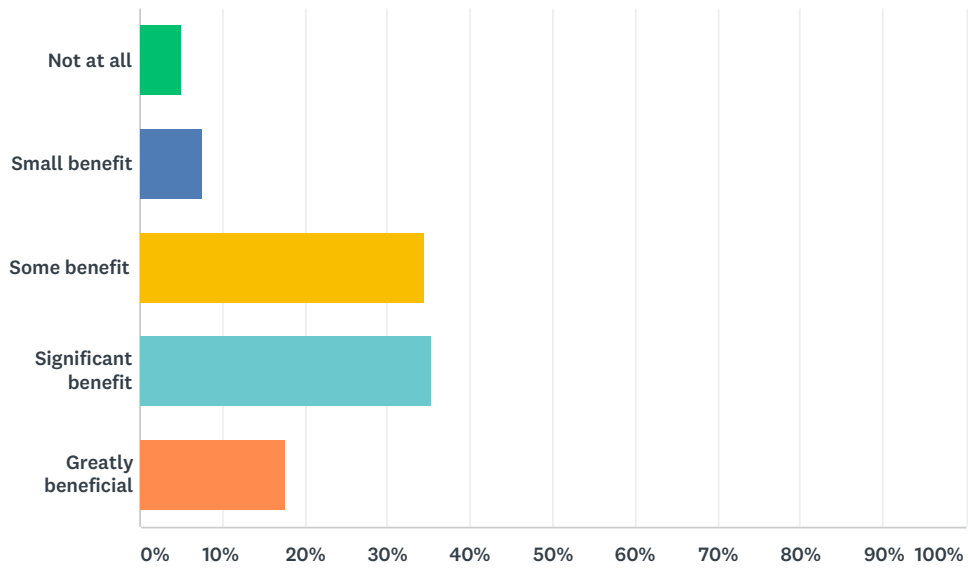
